The Position



The Kelso School District Board of Directors, Kelso, Washington is seeking a highly qualified superintendent of schools. The Board wishes to have the successful candidate assume the responsibilities of the position July 1, 2014.

The Qualifications

The Kelso School District

The 257 square mile Kelso School District serves about 4,600 students. There are 653 staff members, 22 administrators, 298 certified teachers, and 333 classified staff. The district has seven elementary schools, two middle schools, one high school, one alternative high school, and an online high school.

The district has a HiCap (highly capable) program. Counselors have set up several peer groups in every school.

Kelso High School has several students participating in running start with Lower Columbia College (LCC). The KHS Vocational Department has programs for police science, fire science, and health careers through partnerships with Kelso Police Department, Cowlitz 2 Fire and Rescue, and Peace Health. Tech-prep credits are available for students in Career Technical Ed courses at LCC. These classes are offered off campus and available to schools across the county.

Extracurricular activities include football, wrestling, track and field, bowling, soccer, cross country, and other sports. The district has active and successful music and drama departments. All secondary schools participate in regional art shows and competitions.

The assessed valuation for the district is \$1,691,206,496. The operating budget is \$49,884,750.

The district is proud of its reputation for excellent schools and opportunities for young people. Kelso students benefit from a dynamic curriculum, progressive programs and exceptional staff-all who are focused on ensuring that each and every student has an opportunity to achieve academic and personal success.

The district strives to continually improve student achievement by frequently evaluating and strengthening our methods of assessing student progress towards mastery of district and state standards at all grade levels.

Our Community and Region

The Kelso-Longview Community (often referred to as the "twin cities") is located in a scenic corner of SW Washington, 40 miles north of Vancouver, 125 mile southwest of Seattle, and 50 miles north of Portland Oregon. The Pacific Coast is 80 miles to the west. There is a regional airport and an Amtrak station allowing easy access to the area. The combined population of the cities is 48,000.

International corporations and small businesses exist side by side. Historically the area benefited from a timber-based economy, however in recent years manufacturing businesses have located here resulting in a growing economy.

There is an abundance of outdoor recreational opportunities including hiking, bicycling, boating, fishing and hunting. Mount St. Helens National Volcanic Monument is located about 20 miles to the north of Kelso. The area has motorcycle racing, skateboard parks, many local sporting events, including high school, community college, a semi-pro baseball team, and league sports. The community events include the annual Highlander Festival, Go Fourth Independence Day Festival, Cowlitz County Fair and Rodeo, and the "In Honor of Our Children" Pow Wow.

Higher educational opportunities are available from Lower Columbia College in Longview, Eastern Washington University at LCC, Washington State University in Vancouver, Portland State University, and the University of Portland. There are many churches of many denominations available in the area.
