The Position

- Has strong communication skills with demonstrated ability to manage, lead and be approachable in a diverse school district, is visible and active in the community.
- Is fiscally adept, has demonstrated knowledge and experience in managing sizable educational budgets.
- Is an innovative thinker, a problem-solver, and stays informed on current national and local educational issues and trends.

The Community



Home to approximately 25,000 residents and 600 businesses/industries, Grandview, Missouri is located in Jackson County along I49 on the south side of the Kansas City metropolitan area. Situated between Kansas City to its north and west, Cass County to its south, Lee's Summit to its east, and bisected by an interstate, Grandview is easily accessible to rural, suburban and urban communities alike.

From its early days as an agricultural community farmed by future President Harry S. Truman, Grandview evolved to become a first-tier, multicultural suburb. Residents enjoy small town living conveniently close to major city amenities. Tree-lined streets, a community center, numerous parks and trails, and nearby Longview Lake provide a variety of recreational opportunities for the enjoyment of Grandview citizens.

The Grandview community is served by the Grandview C-4 Public School District, a number of parochial and private schools, a Christian University and Longview Metropolitan Community College. A small northern portion of Grandview is served by the Hickman Mills Public School District. Over 25 churches of all faiths provide services from traditional to contemporary allowing opportunities for spirituality and interaction among all age groups and faiths.

Grandview, Missouri celebrated its first 100 years in 2012 and proudly begins the next 100 with optimism and anticipation.



Grandview Consolidated School District #4 (GC-4) was established in 1914. Today it proudly serves a diverse student population of more than 4,200. There are 605 staff members, 26 administrators, 329 certified teachers, and 250 classified staff. The district has been fully accredited throughout its history, scoring in the "Distinction in Performance" status in recent years.

District boundaries encompass the majority of Grandview,

Missouri, as well as portions of south Kansas City on the west of the district and Lee's Summit on the east, with a total population of 32,000.

GC-4 has an early childhood center (High Grove), four elementary schools (Belvidere, Butcher-Greene, Conn-West and Meadowmere), one K-8 school (Martin City), one 6-8 grade middle school (Grandview Middle School/GMS), one 9-12 grade high school (Grandview High School/GHS) and the Center for Alternative Instructional Resources (CAIR).





Approximately 79% of GC-4 students receive free/reduced lunches. The assessed valuation of the district is \$427,771,406 with an operating budget of approximately \$50,000,000.

GC-4 is committed to using high quality instruction to ensure college/career readiness for all students. The district is structured using Small Learning Communities (SLCs), and career path "houses" at GHS to enhance rigor, relevance and relationships.

The Board of Education

The Grandview C-4 School District Board of Education consists of seven community members elected to three year terms. The tenure of the Board members ranges from one to nine years.

- A letter setting forth personal qualifications, experiences and reasons for interest in the position
- A current résumé
- A completed application form
- Reference letters, certificates and licenses, and academic transcripts from colleges/universities indicating degree(s)
