

## ***The District***

Chambers Public School has an enrollment of 110 students in K-12. There are 34 staff members: one administrator, 18 teachers, and 15 classified. The district covers 362 square miles. The students attend classes in one school building.



Extracurricular activities include: volleyball, football, basketball, golf, cross country, track, drama, speech, band, yearbook, FCCLA, FFA, National Honor Society, Student Council, Quiz Bowl, Scholastic Contests, Industrial Tech contests, business contests, and math contests.

The assessed valuation of the district is \$308,634,634, with an operating budget of \$3,018,962.

The Board of Education consists of six members who are elected to serve four-year terms. The incumbency of the board members ranges from one to thirteen years.
