The Position

The Lakeview Community Schools, Columbus, Nebraska, Board of Education is seeking a highly qualified and fully certified Superintendent. The Board wishes to have the successful candidate assume the responsibilities of the position July 1, 2025.

- A visionary, growth-oriented leader who thinks creatively, approaches challenges with innovative solutions, and strategically drives progress to meet the district's evolving needs.
- An instructional leader with a strong educational background who prioritizes student opportunities, values all
 activities, champions excellence in instruction, and exemplifies servant leadership in fostering success for all
 learners.
- A leader with a strong budgetary background, business acumen, and strategic thinking skills, who is experienced in securing grants and actively engaged in legislative processes to support district goals.

Community

Lakeview Community Schools, located on the north side of Columbus, Nebraska, serves a community of approximately 24,464 residents and offers a small-school atmosphere with big-school opportunities. These opportunities are made possible through strong partnerships with local businesses, community organizations, and educational institutions.

In collaboration with Central Community College, located just a few miles from Lakeview Jr.-Sr. High, students can access over 40 hours of dual-credit coursework, taken either at the high school or on the college campus. Columbus Community Hospital provides critical support with a full-time certified athletic trainer for student activities and a licensed health professional to teach Health Science courses, enabling students to complete a Health Science Career Pathway, including courses like Health Science I, II, III, and CNA certification.





Lakeview also works with local businesses such as Behlen Manufacturing, Truck Center, Platte Valley Equipment, and Habitat for Humanity to provide students with valuable work-based learning experiences. Programs like Drive for Five—offering Mock Interview Day, Reality 101, Vehicle Day, and Banking in Schools—further enhance community ties and prepare students for successful futures.

These partnerships, along with the district's commitment to excellence, ensure that Lakeview students are well-equipped for college, careers, and lifelong success.

The District

Lakeview Community Schools is a public school district serving approximately 1,050 students from suburban and rural Columbus, as well as the nearby communities of Platte Center and Creston. The district comprises three schools: Lakeview Junior-Senior High School, Shell Creek Elementary, and Platte Center Elementary, and welcomes the majority of 9th-grade students from Christ Lutheran and St. John's Lutheran parochial schools.

The district employs 141 staff members, including 5 administrators, 84 certified teachers, and 52 support staff. Over the past several years, Lakeview has undergone significant facility upgrades to accommodate growth. These include a 2009 addition to the Junior-Senior High School for 7th and 8th grades, the initial expansion of Shell Creek Elementary in 2013, and a 2019 bond-funded renovation and addition to the Junior-Senior High School in 2021, and a second expansion to Shell Creek in 2022. Preschool programs were introduced in 2020 at Platte Center Elementary and expanded to Shell Creek Elementary in 2022.

Lakeview offers a wide range of academic and extracurricular opportunities, including Advanced Placement (AP), dual credit, college-level courses, and a robust STEM and agriculture education program. Career education, English as a Second Language (ESL), and migrant education programs further support students' diverse needs. The district consistently demonstrates academic excellence, with NSCAS and ACT scores exceeding state averages.

The assessed valuation for the district is \$1,932,343,183. The operating budget is \$17,543,484.
